4 **Minutes for the previous meeting held on 16th April 2008.**

5 **Approval for the 2007/8 accounts.**

Councillor Nick Moss proposed the already published accounts for 2007/8 which had been approved by both internal and external auditors and he

confirmed they were within the proposed budget. Seconded by Pat Fea and accepted by the meeting.

6 **Report from David Peters, Chairman of the Council**

David Peters referred to his circulated written report and updated some items. He started by encouraging people to think about the objective of the meeting, which he hoped would be to get together to develop ideas for the future success of Gerrards Cross.

BCC Waste Development Plan

Following the removal of Wapseys Wood as a possible site for an incinerator for Domestic Waste, we are strongly of a view that new and more flexible processes need to be considered in place of large incinerators

Tesco

The project is moving forward on the repair of the tunnel and it is now programmed to be finished by late 2010.

There has been much criticism about the state of the Packhorse Road with the lorry movements and he was happy to say that a concrete apron at the exit has now been created and the wheel washer will be moved close to the road to help ensure the road is kept cleaner.

Waitrose

The Planning application for a shop down Station Road was withdrawn as the developers and South Bucks District Council officers have been unable to agree on planning requirements.

Verdent

The new cleaning and refuse removal contract has been very successful for the village but we must continue monitoring the standards and encourage the public to help keep it clean.

Volunteers

The Council are looking for more local residents to work with Councillors on local issues, bring their specific skills for the benefit of the local community.

Communication

Councillor May has worked to improve areas of communication and we thank her for all her work. The notice board and web site are regularly updated and well used. Please feed back to us on any ideas for improvements on what you think we should be doing.

Grammar Schools Catchment Areas

After the disaster this year I am pleased that the County Council has made a small step for the next year and announced that there will be a full independent review of the catchment areas for the future.

Cllr' Peter Hardy

There is no progress for this year but in 2010 John Hampden has been added as a third boys' catchment school. Peter Roberts and I have been working for the

Sue Hatton

I am concerned that the selection process does not seem to pick up the parents that move to the area for a short term just to get in the catchment areas. There are as many as ten this year. Is there nothing that can be done to stop this unfair practise?

I will take your concerns back but it is always difficult to stop this type of practice.

7 Reports from Peter Hardy and Peter Roberts BCC – our County Councillors

Cllr. Peter Hardy

It is essential that we stop using distance as an arbiter for selection into Grammar Schools.

Land fill tax has just been increased from £8m to £15m adding an additional cost to the system as it is.

The state of the highways has been of concern and we are working with BCC to carry out a patching system which has been successful to a degree. But the situation has been made worse by the very bad weather.

Cllr.L Campkin

I have been involved with the Grammar School project for some time, what would you think would be the way to move things forward and getting local residents involved to support the independent report and get the correct result?

Cllr. Peter Hardy

We need show major public concern, which could involve a well attended public meeting later in the year.

Cllr Peter Roberts

I will be leaving the County Council on the 4th June 2009.

Grammar Schools

There have been problems since 2005 when suggested changes had to be made because of a huge opposition from North Amersham and BCC had to back down.

David Peters with the support of the meeting thanked Councillor Roberts for all he had done for the Parish.

The dust and grit from the lorries is causing residents and shop keepers a lot of problems. What are the Parish Council doing about this and the general state of the village?

Costain maintains a log of all comments and complaints received. SBDC also reviews Costain's log of complaints each month. There are four monitors operating continuously with electronic download to SBDC at regular intervals.

The Environment Health Officer should be reviewing all matters relating to the site regularly.

The Parish Council and SBDC have had meetings with Costains checking various matters.

I own Cardella and the increased dust is causing a problem with our stock, the air quality is deteriorating, the sweeper is noisy and creates dust that comes into the shop, I have complained to SBDC David Gilmore.

Lady Hurn

SBDC monitoring of the site concerns her as the Olu Sokoya (SBDC) states he has never seen a cloud of dust over the site.
